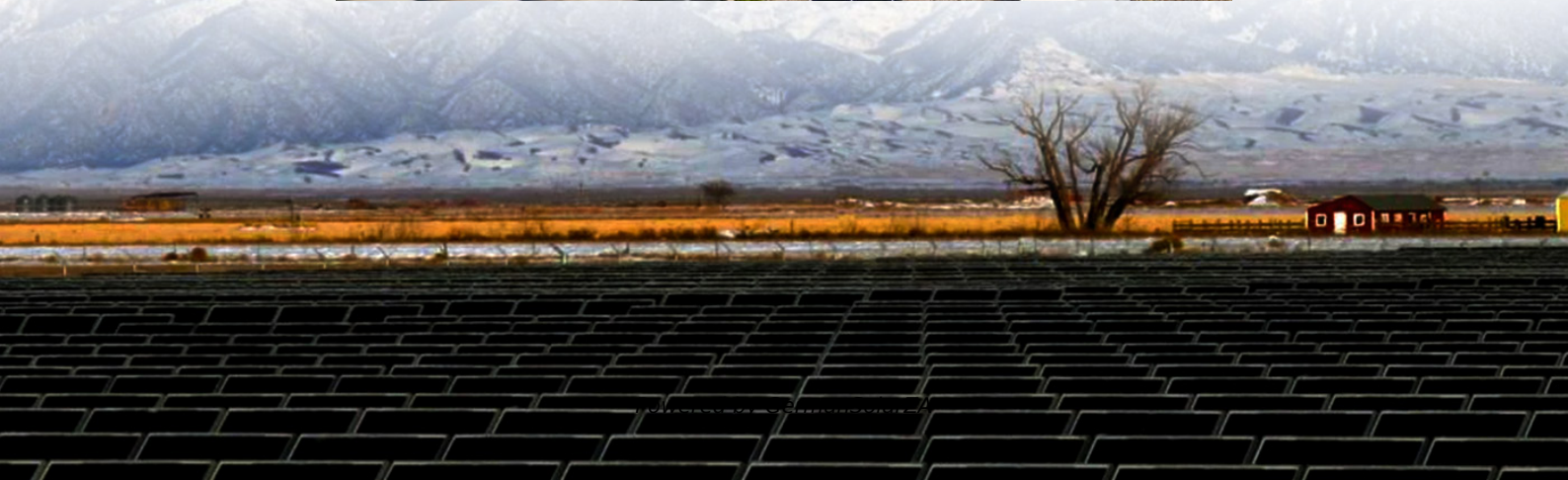

A new financing agreement has been signed to support the development of rooftop solar power projects in Singapore.

As part of the renewable energy deployment, the photovoltaic panels will provide power to common areas at the installation sites, contributing to the Singapore Government's objective of achieving a minimum of 2 gigawatts-peak of installed solar capacity by 2030.

Why is project finance difficult for energy storage?

It has traditionally been difficult to secure project finance for energy storage for two key reasons. Firstly, the nascent nature of energy storage technology means that fixed income lenders and senior debt providers are naturally risk averse.

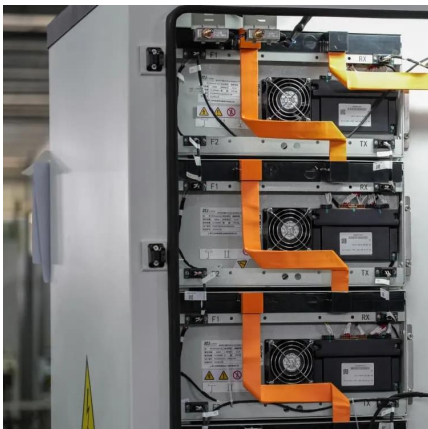

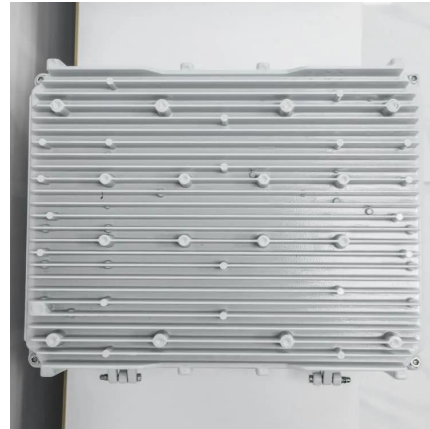
