Do VAT rates affect tariffs in Guinea?

VAT rates need to be considered along with tariffs, as they can significantly affect the final costs of goods. For traders, it is advisable to consult with customs agents or utilize resources provided by the Guinea customs administration to understand the entire scope of applicable taxes.

What is the tariff rate in Guinea?

Includes information on average tariff rates and types that U.S. firms should be aware of when exporting to the market. Guinea has a flat tariff of 33 percent on most imports. However, some “privileged regimes” (see Establishing an Office), public institutions, and donor organizations can receive exemptions.

Does Guinea have a tariff on imports?

Guinea has a flat tariff of 33 percent on most imports. However, some “privileged regimes” (see Establishing an Office), public institutions, and donor organizations can receive exemptions. Privileged regimes have an exemption on import duties for machinery and equipment for use on investment projects and a six percent duty on raw materials.

What is a one-page tariff profile?

One-page profiles offer more detailed tariff data broken down by product groups for each economy based on the WTO's Multilateral Trade Negotiations (MTN) categories, the product classification system used by the WTO for trade statistics and policy analysis. Also shown are the tariffs imposed on its exports by its main trading partners.

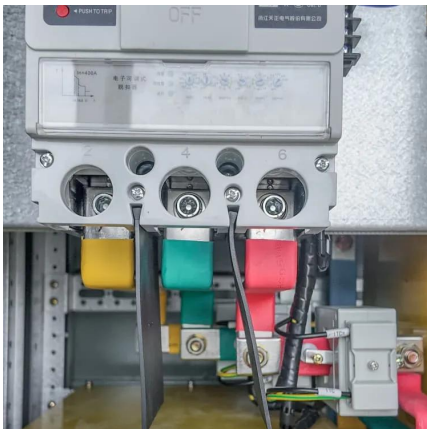

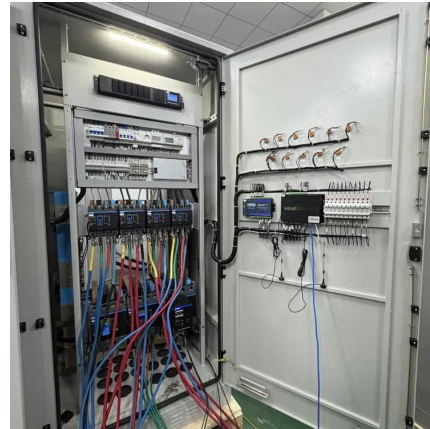

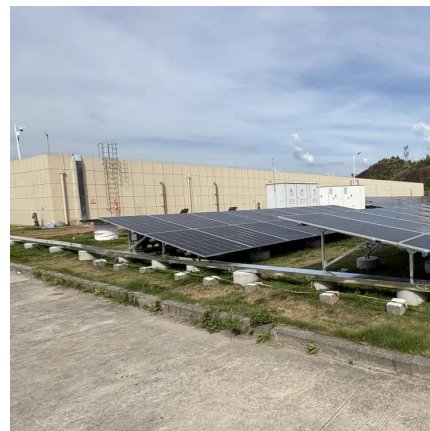
